OFFICIAL RULES for the "2015 AeroShell Aerobatic Team Ride Along Sweepstakes" ("Sweepstakes")

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. ELIGIBILITY: Open only to those who are at least eighteen (18) years old at the time of entry. Winner must weigh 250 lbs or less and be able to enter and exit the cockpit under his/her own power at the time of the Aerobatic Team flight. AeroShell and the AeroShell Aerobatic Team reserve the right to refuse flight in the event of any safety concerns. Employees of Equilon Enterprises LLC dba Shell Oil Products US ("Sponsor") and its parent, affiliates and subsidiaries, participating advertising and promotion agencies, and those entities involved in the preparation of materials for, administration and/or execution of this Sweepstakes (collectively "Promotion Entities") and immediate family members and/or those living in the same household (whether or not related) as any of the foregoing employees are ineligible. Sweepstakes starts at 9 a.m. Central Time ("CT") on July 20, 2015, and ends at 3 p.m. CT on July 25, 2015 ("Promotion Period"). Sponsor's computer will be the official timekeeping device of this Sweepstakes.

2. HOW TO ENTER: To enter during the Promotion Period ("Entry") fill out the entry form on a tablet available at the AeroShell booth, Hanger C, #3072, during EAA AirVenture.

Entrants, at their option and discretion, may elect to "opt-in" to receive future marketing and promotional communications from Sponsor via email. Choosing to "opt-out" or "opt-in" will not affect entrants' chances of winning.

The winner is subject to determination of eligibility and verification before any prize will be awarded. All eligible Entries received will be entered into a random drawing held by Sponsor (or its authorized representative) on or about 4 p.m. Central Time, July 25, 2015.

All winners are subject to determination of eligibility and verification before any prize will be awarded. By entering, all entrants and winners agree to be bound by these Official Rules and the decisions of the Sponsor and its authorized representatives, which are final and binding in all matters concerning this Promotion. **Limit one (1) Entry per person.** More than the stated number of allowable Entries per Entry Period is not permitted. The potential Prize winner will be contacted via email in order to notify him/her that he/she has been selected as a potential winner and to verify eligibility.

4. PRIZE, ODDS OF WINNING: PRIZE (1): One entrant will be randomly selected to receive 2 rides with the AeroShell Aerobatic Team; one for the winner and one for the winner's guest. The 2 rides must be taken at the same airshow and time. The guest must be at least eighteen (18) years old at the time of flight and weigh 250 lbs or less and be able to enter and exit the cockpit under his/her own power at the time of the Aerobatic Team flight.

AeroShell and the AeroShell Aerobatic Team reserve the right to refuse flight in the event of any safety concerns. The 2 rides must be taken between August 1, 2015 and July 1, 2016 at an airshow where the AeroShell Aerobatic Team is scheduled to perform. Sponsor will provide this information to the winner as it becomes available. Winner must give 30 days advance written notice to AeroShell (contact information will be provided to the winner) prior to selecting the location and date for the flight. The winner and guest will be responsible for all expenses related to travel to, from, and during the airshow of choice.

Total Approximate Retail Value ("ARV") of the Prize: \$500

All federal, state and local taxes, if any, on Prize are winner's responsibility. Winner will not receive the difference between the actual value and the ARV.

A. Odds of winning the Prize depend on the number of eligible Entries received.

B. All costs, fees and other expenses not specified in these Official Rules are the winner's sole responsibility.

C.
